Applicant understands and agrees to these conditions which apply to any permit to use an air curtain incinerator:

- 1 Use of the air curtain incinerator shall be initiated only after initial start-up approval has been given by the Indian River County Fire Prevention Bureau and a site review has been conducted. Such approval shall be granted after inspection reveals that the air curtain incinerator has been properly located and installed in accordance with laws, the material to be burned has been properly dried. The permittee shall request an inspection at least 72 hours before he commences initial operation of the air curtain incinerator.
- 2 The permittee shall call the Indian River County Fire Prevention Bureau at 772-226-1880, prior to that days start up of the air curtain incinerator for approval to burn.
- 3 Use of the air curtain incinerator shall be discontinued at any time that the Division of Forestry or local fire authority has determined that weather conditions are unfavorable for safe burning. The permittee may be so advised at the time the permittee calls the Indian River County Fire Prevention Bureau.
- 4 Additional conditions consistent with recommendations of the Division of Forestry or local fire authority or necessary for compliance with this ordinance or applicable laws or rules may be included in any permit to use an air curtain incinerator.
- 5 No burning is allowed on Indian River County observed holiday and weekends.
This permit will expire 180 days from issuance
