NOTES

1. Provide **dimensioned** plot plan diagramming the display area. Plot plan shall include the placement of devices, location from where operator will discharge fireworks, location of any performers, location of the audience and the lines behind which the audience will be restrained. Additionally, show the location of highways, overhead obstructions, nearby trees, telephone lines and other lines of communication. When necessary, a sectional drawing shall be provided.

2. Include **complete** description of all fireworks to be displayed, specifying if single or multiple break shells. If set pieces are used, they shall be described in detail. Provide complete description of additional items to be displayed.

3. Insurance Required: A copy of the Certificate of Insurance must be filed with this application which complies with the following requirements (refer to Section 791, Florida Statutes, and Florida Administrative Code 69A-60):

- Limits of bodily injury and property damage may be not less than one million dollars (\$1,000,000.00) combined single limits for each occurrence.
- A statement must be included that the insurer will not cancel the insured's coverage without 15 days prior written notice to the Fire Marshall.
- Indian River County shall not be responsible for any premiums or assessments involving the policy.
- The licensed pyrotechnic operator supervising/discharging the display must be included as additional insureds.

REQUIREMENTS FOR RETAIL SALES OF SPARKLERS
WITHIN A TEMPORARY TENT ONLY

TEMPORARY PERMIT - VALID FOR 14 DAYS

1. Only items that are in accordance with the *Florida Statute 791.01* will be permitted to be sold in Indian River County – sparklers/novelty items/noisemakers as defined by FS 791. (4)(A) Fireworks are prohibited for the retail sale within Indian River County.
2. Copy of Florida License
3. Proof of Liability Insurance
4. Wholesalers Certificate
5. Inventory List (as approved by the Florida State Fire Marshal)
6. Special Event Application
7. Schematic (floor plan) of temporary tent
8. Statement of Property Owner Permission
9. Copy of Certificate of Flame Resistance of temporary tent
10. Check in the amount of \$100.00 – payable to: IRC Fire Rescue
